



Participant Sign On

All participants must sign the below declaration on arrival before entering any live areas or participating in any activity.

Risk: I agree to take part in the activity which I understand can be dangerous and may cause minor injury, major injury, disability or death. I confirm that I am participating of my own volition. I acknowledge that participation in this event entails both known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property or to third parties. It is understood that such risks simply cannot be eliminated without jeopardising the essential qualities of the activity. I agree to indemnify and to keep indemnified PSR Hire Ltd (hereinafter 'the Company') and the circuit at which the event is being held, as well as their officials, driving coaches, representatives and agents and any other persons using the circuit, from claims of damage to property or myself or passengers, however caused. I declare to the best of my knowledge and belief that I possess the standard of competence necessary for this activity. I agree that I am participating entirely at my own risk.

Liability: Neither the circuit where the event is being held, the Company nor any of its directors, employees or their representatives will be liable for loss or damage arising out of or in connection with the use of the circuit where the event is being held. This is a comprehensive limitation of liability that applies to all damages of any kind, including (without limitation) compensatory, direct, indirect or consequential damages, loss or damage to property and claims of third parties.

Unavailability / Non-Performance: I accept that no claims can be made against the Company or the circuit at which the event is taking place in respect of unavailability of the circuit or vehicle for any reason. We uphold the right to withdraw the participation of any advertised vehicle at any point without prior notice. In this situation, I understand that a substitute vehicle will be offered, and no refund will be available.

Consumer Rights: Notwithstanding the foregoing, I understand that none of the exclusions or limitations in this agreement are intended to limit any rights I may have as a consumer under local law or other statutory rights which may not be excluded nor in any way to exclude or limit the Company's liability to me for death or personal injury caused by the negligence of its employees or agents.

Health: Drivers only (Including under 18's). I declare to the best of my knowledge and belief I am physically and mentally able to participate in the activity and I do not suffer from any permanent or temporary illness or disability that may affect my ability to participate. I am not currently taking drugs (whether prescribed or otherwise) that may interfere with my ability to take part in this activity, and I am not under the influence of alcohol. I will not consume any alcohol from the time I sign this waiver until the completion of this activity.

Instructions: I agree to listen to the driver briefing and all instructions given to me by all members of the Company's staff. I understand that accidents can happen, which may result in me being liable for the first £5,000 worth of any damage to each of the vehicles I drive. I understand that opting for the damage waiver will exempt me from liability of the cost of repairs for all accidental damage to these vehicles. I understand that this damage waiver will not remain in effect should the cause of damage be deemed by the Company to be deliberate or due to reckless, careless or negligent driving, or failing to listen to the driving coaches' commands. I understand that all driving activity is recorded and consent to the Company using this video to assess any crash or damage. In the interests of safety, the Company or driving coaches may exclude you from further participation in the activity if they think you are driving recklessly or dangerously.

Misc: I agree that I will use all restraints (seatbelts or harnesses) provided in all vehicles and will ensure they are fitted correctly prior to moving off. I authorise and permit the Company (and third parties connected to the event) to administer first aid to me and to authorise such other medical treatment and transportation as may be recommended by physicians and other medical personnel, in the event of illness, accident or injury to me. You should be aware that other participants will be on the track at the same time as you. We take photographs and video footage of you during this event and may use such photographs or footage (including your likeness and image) for future promotional, marketing, and publicity purposes in any media worldwide without notice or payment. I acknowledge that driving conditions may change due to weather, behaviour of other cars on track or because the grip levels and braking efficiency of the vehicle may be affected by tyre and brake temperature and I will drive appropriately at all times and keeping these variables in mind and I participate of my own free will and am free to withdraw from the event at any time without penalty.
